RESOLUTION AUTHORIZING THE EXECUTION OF AN INTER-LOCAL AGREEMENT BETWEEN THE JCHA AND BAYONNE HOUSING AUTHORITY (BHA) TO CONDUCT HOUSING QUALITY STANDARD (HQS) INSPECTIONS AT ARLINGTON GARDENS FOR A PERIOD OF ONE YEAR

WHEREAS, the Jersey City Housing Authority (JCHA) is prohibited from performing Housing Quality Standard (HQS) inspections of Housing Choice Voucher (Section 8) Program participant apartments located in buildings owned by the JCHA; and

WHEREAS, the JCHA is required to have such HQS inspections conducted for Housing Choice Voucher (Section 8) Program participants residing at Arlington Gardens, which is owned and operated by the JCHA; and

WHEREAS, the Bayonne Housing Authority (BHA) has agreed to perform the HQS inspections of JCHA Housing Choice Voucher (Section 8) Program participant apartments at Arlington Gardens at a cost of \$35 for each HQS inspection, and BHA has satisfactorily conducted the above referenced inspections at the same cost last year; and

WHEREAS, General Counsel has reviewed the Inter-Local Agreement with the BHA (attached) and finds it in compliance with State and Federal Procurement regulations; and

WHEREAS, the JCHA has determined that the cost for this service is reasonable, and the availability of funds has been established.

WHEREAS, the JCHA has utilized State and Co-operative contracts in the past recognizing the benefits, which allow the JCHA to reduce expenses (i.e. advertising, streamline administrative and management processes regarding the public bid process) and expedite the delivery of service and supplies to JCHA developments; and

WHEREAS, Millennium, has the necessary staff and expertise to provide long term maintenance, repair and modernization service for the JCHA's developments; and

WHEREAS, the availability of funds has been established.
