



RESOLUTION AUTHORIZING CONTRACT EXTENSIONS OF PROJECT BASED HOUSING ASSISTANCE PAYMENT CONTRACTS UNDER THE HOUSING CHOICE VOUCHER (SECTION 8) PROGRAM TO FRED MARTIN APARTMENTS

WHEREAS, the Jersey City Housing Authority (JCHA) has been awarded a total of 4649 Housing Choice Vouchers (Section 8) by the U.S. Department of Housing and Urban Development (HUD) to provide rental subsidies for low income households (below 50% of median income) to rent affordable apartments in the private market; and

WHEREAS, in accordance with Federal Regulations 24 CFR 983.5, the JCHA is eligible to administer a Project-Based Voucher Program (up to 20% of budget authority is allowed for vouchers to be assigned to a specific development) in addition to its Tenant-Based Voucher Program (vouchers issued to individual households); and

WHEREAS, the JCHA previously awarded a total of 10 Project Based Vouchers to Fred Martin Apartments, and the Project Based Contract will be expiring in Calendar Year 2021, and

WHEREAS, The Project Based Regulations allows PHA to extend the Project Based Contract for an additional 5 years for a maximum of 20 years.

NOW THEREFORE BE IT RESOLVED that the JCHA Board of Commissioners authorizes a 5-year extension of Project Based Housing Assistance Payment Contracts to continue to provide Project Based Vouchers to Fred Martin Apartments,



RESOLUTION CONFIRMING THE SUBMISSION OF AN APPLICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR FISCAL YEAR 2021 FAMILY SELF-SUFFICIENCY PROGRAM GRANT FOR THE HOUSING CHOICE VOUCHER (SECTION 8) AND PUBLIC HOUSING PROGRAMS

WHEREAS, the Jersey City Housing Authority (JCHA) is required to administer a Housing Choice Voucher (Section 8) Family Self-Sufficiency (FSS) Program for a minimum of 320 participants, which is based on the number of Vouchers that the JCHA was awarded between October 1, 1992 through September 30, 1998, and each year the minimum required number of participants is decreased by the number of Program graduates; and

WHEREAS, a total of one hundred sixty-one (161) FSS participants have graduated from the Program since its inception resulting in the current minimum requirement of one hundred fifty-nine (159) FSS Program participants; and

WHEREAS, under the Quality Housing and Work Responsibility Act of 1998 (QHWRA), FSS, which became a voluntary program for participants as of October 21, 1998, encourages and assists low-income Housing Choice Voucher (Section 8) participants to achieve empowering goals such as higher education, employment and homeownership that will lead to economic independence and self-sufficiency; and

WHEREAS, a Housing Choice Voucher (Section 8) participant's income increases, the JCHA's portion of the rental payment is decreased; however, when an FSS participant's income increases, the amount by which the JCHA would decrease its rental payment is invested in an escrow account and serves as an incentive for completing the FSS Program and achieving. The goals established by the participant at the beginning of the five-year contract period; and

RESOLUTION CONFIRMING THE SUBMISSION OF AN APPLICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR FISCAL YEAR 2021 FAMILY SELF-SUFFICIENCY PROGRAM GRANT FOR THE HOUSING CHOICE VOUCHER (SECTION 8) AND PUBLIC HOUSING PROGRAMS

WHEREAS, pursuant to the Section 8 Management Assessment Program (SEMAP), SEMAP Indicator # 14 measures a Public Housing Authority's (PHA) success rate in enrolling Section 8 participants in the FSS Program for which the JCHA scored 10 points out of the maximum 10 points; and

WHEREAS, for the last twenty-three (23) years the JCHA has been awarded funding by the U. S. Department of Housing & Urban Development (HUD) under its Housing Choice Voucher Family Self Sufficiency Program Coordinator Funding; and

WHEREAS, HUD issued a Notice of Funding Availability (NOFA) for FY2021 Housing Choice Voucher Family Self-Sufficiency Program funding application, with a due date of September 7, 2021; and

WHEREAS, the JCHA applied for funding for one (1) FSS Supervisor and three (3) FSS Coordinators, in the amount of \$275, 886 and the JCHA finds that the provision of these positions has facilitated achieving FSS Program objectives by linking Program participants to the supportive services needed to achieve self-sufficiency.

NOW, THEREFORE, BE IT RESOLVED that the JCHA Board of Commissioners confirms the submission of an application (as detailed in the attached memo) to HUD for funding for one (1) FSS Program Supervisor and three (3) FSS Coordinators in an amount of \$275,886 subject to HUD review and approval.





WHEREAS, the Department of Housing and Urban Development has issued a Notice of Funding Availability for Homeless Programs, 24 CFR 578.15, eligible project applicants for the CoC Program Competition are nonprofit organizations, States, local governments, and instrumentalities of State and local governments, and public housing agencies, as such term is defined in 24 CFR 5.100, without limitation or exclusion; and

WHEREAS, The CoC Program (24 CFR part 578) is designed to promote a community-wide commitment to the goal of ending homelessness; to provide funding for efforts by nonprofit providers, States, and local governments to quickly re-house homeless individuals, families, persons fleeing domestic violence, and youth while minimizing the trauma and dislocation caused by homelessness; to promote access to and effective utilization of mainstream programs by homeless individuals; and to optimize self-sufficiency among those experiencing homelessness; and

WHEREAS, the JCHA has successfully administered the 38 Vouchers under the COC Programs and would like must request funding to continue to administer the Vouchers.



WHEREAS, the mission of the JCHA is to develop and manage housing of choice of the highest standards, which is safe, affordable, sustainable and accessible, and to partner to foster resident responsibility and self-sufficiency through effective programming and partnerships; and

WHEREAS, the JCHA is committed to providing quality programming and resident services for the purpose of fostering self-sufficiency among residents and positive community engagement; and

WHEREAS, almost 500 youth ages six to fourteen reside in JCHA's five family public housing developments including Marion Gardens, Curries Woods, Booker T. Washington, Hudson Gardens, and Holland Gardens; and

WHEREAS, a growing body of evidence shows that an integrated focus on academics, enrichment activities, expanded learning opportunities, and positive youth development are critical to improving student success; and

WHEREAS, contracts (#101258 and # 101259 respectively) were awarded on October 4th, 2018, to Boys and Girls Clubs of Hudson County to serve Marion Gardens, Curries Woods, and Booker T Washington and to Jersey Art Exchange to serve Hudson Gardens and Holland Gardens for a period of one (1) year in amounts not to exceed \$79,028.40 and \$56,215.00 respectively for the period 11/1/2018 to 6/30/2019; and

WHEREAS, the New Jersey Local Public Contract Law N.J.S.A 40A allows the contract specifications to include a term option clause for a period of five (5) years in one (1) year increments; and

WHEREAS, the JCHA and Boys and Girls Club mutually agreed to exercise the term option clause for a second (2nd) year in September 2019, for a third (3rd) year in Sep-

Washington, Hudson Gardens, and Holland Gardens; and

WHEREAS, the availability of funds has been established.

NOW THEREFORE BE IT RESOLVED, that the JCHA Board of Commissioners confirms that the JCHA may exercise the one (1) year option in the existing contracts to Boys and Girls Clubs of Hudson County at a rate of \$115,629.83 to serve Marion Gardens, Curries Woods, Booker T. Washington, Hudson Gardens, and Holland Gardens under the same terms and conditions that includes a contingency of five (5) percent to cover program growth or related services beginning September 2021 and ending June 2022.






